## **MOISD Updates/News:**

Superintendent Locke discussed the following changes for the upcoming 2019-20 school year:

- Emotionally Impaired Classroom/Students: This classroom will be moving from Crossroads Charter Academy to the Mecosta-Osceola ISD Education Center.
- Mid Michigan Classrooms: Location of Mid Michigan Classrooms at the MOISD Resource Center.
- o **Eastwood:** Classroom additions and traffic reorganization and direction
- US10 Coordidor relocation of the MOISD US10 Corridor office from MRYH/YOA to Pineview Homes. The change is in office location only, supervision of the US10 Corridor will remain the same.

Assistant Superintendent Klumpp reported on summer projects that are being completed to accomplish the above.

- ➤ Superintendent Locke spoke about the highly competitive job market and that the movement of staff was to be expected. He discussed the MOISD exit interview process.
