The regular meeting of the Mecosta-Osceola Intermediate School District Board of Education was held on Monday, Monday, May 10, 2021, at 6 p.m. in the Resource Center of the Mecosta-Osceola Intermediate School District, 15800 190th Avenue, Big Rapids, Michigan 49307.

President Wilkerson officially called the meeting to order at 6:01 p.m.

Under regular order of business, President Wilkerson asked if there were any "Additions or Changes to the Agenda." There were none.

President Wilkerson then asked if there were any "Communications." There were none.

Under "Superintendent's Report"

Board Showcase:

Superintendent Locke announced that the Director of Technology, Fred Sharpsteen, would be presenting. Mr. Sharpsteen presented on the MOP program and LEA usage of the MOP. He explained how technology supports the MOISD and LEA's and the different types of services being provided. He gave an overview of what LEA locations the MOP Tech. support team are supporting. Mr. Sharpsteen reported on cybersecurity, data center updates, ticket timeline statistics, challenges and opportunities, and the need for increased technology and Chromebook repairs. He spoke on the many collaborations the MOISD is part of locally, as well as state collaborations.

• Department Updates:

- Superintendent Locke asked the Board if there were any questions or feedback. There were comments from the Board on various sections of the report.
- MOISD Updates/News- Superintendent Locke discussed the following:
 - There is a lot going on. He thanked the MOISD team, specifically the administrators, for their willingness to hold the line during a crazy year and for the tremendous strides forward.
 - New and innovative opportunities: in the middle of a pandemic, students and local districts, and families are being offered opportunities.
 - Lansing: he reported on his days spent in Lansing a couple of weeks ago. He met with multiple State legislators in the House and the Senate. He approached them on the following:
 - The one size fits all approach to ISD is insufficient when it come to funding.
 - Lack of funding for rural ISDs
 - **COVID Vaccine Clinics:** the ISD has hosted a couple of vaccine clinics with the Health Department at the MOCC, and they appear to have been successful.
 - Recent Health Department Announcement: we met with Dr. Morse and the Health Department Officer for DH10 to make sure we are following the most up-to-date guidelines.

No. 26... Consideration of Reconfirmation of the Mecosta-Osceola ISD Extended Continuity of Learning Plan. Superintendent Locke reviewed the report for the April 2021 Extended COVID-19 Learning Plan Reconfirmation documentation with the Board. He reported attendance rates and indicated there is no plan to change anything up at this time. We will continue to offer face-to-face instruction. There were no questions from the public.

Patience Nemeth will distribute the Superintended evaluation electronically to the Board. The Board will send the completed evaluation back to Patience on June 9, 2021. We will have a closed session on June 14, 2021, during the regular Board meeting.
